#### City of Santa Paula water is possibly contaminated with Unknown Substances

#### DO NOT DRINK YOUR WATER

Failure to follow this advisory could result in illness.

An unknown substance may have been added to the drinking water supplied by The City of Santa Paula due to a recent Break-In at Main Reservoir Storage Tank. The tank has been taken offline and will be drained and disinfected before returning to service. The State Water Resources Control Board, Ventura County Environmental Department, and The City of Santa Paula Water System are advising specified areas in The City of Santa Paula to NOT USE THE TAP WATER FOR DRINKING AND COOKING UNTIL FURTHER NOTICE. Map of the affected areas are on the following 4 pages.

#### What should I do?

- <u>DO NOT USE YOUR TAP WATER---USE ONLY BOTTLED WATER.</u> Bottled water should be used for all drinking (including baby formula and juice), brushing teeth, washing dishes, making ice, food preparation and bathing **until further notice**.
- **DO NOT TRY AND TREAT THE WATER YOURSELF.** Boiling, freezing, filtering, adding chlorine or other disinfectants, or letting water stand will not make the water safe.
- Potable water is available at the following location (please bring your own water containers): Water Treatment Plant at 532 Main St., Santa Paula, CA 93060 (behind the Community Center) on June 24, from 6pm to 9pm. Beginning June 25, and until further notice, water will be available from 6am to 7pm.

# We will inform you when tests show that the water is safe again. We expect to resolve the problem within 24-72 hours.





# **GENERAL AFFECTED AREA 1 (enclosed in red line)**










