

The undersigned is informed and believes that:

COUNT 1

On or about November 05, 2023, in the above named Judicial District, the crime of INVOLUNTARY MANSLAUGHTER BY AN UNLAWFUL ACT, in violation of Penal Code 192(b), a Felony, was committed by LOAY ABDEL FATTAH ALNAJI, who did unlawfully kill a human being, to wit, Paul Kessler, without malice, as a proximate result of the commission by said defendant of an unlawful act, to wit, a violation of Section 242 of the Penal Code, not amounting to a felony.

Special Allegation 1

It is further alleged that in the commission of the foregoing offense, the defendant personally inflicted great bodily injury on another person, other than an accomplice, within the meaning of Penal Code Section 1192.7(c)(8).

COUNT 2

On or about November 05, 2023, in the above named Judicial District, the crime of BATTERY WITH SERIOUS BODILY INJURY, in violation of Penal Code 243(d), a Felony, was committed by LOAY ABDEL FATTAH ALNAJI, who did willfully and unlawfully use force and violence upon the person of Paul Kessler, resulting in the infliction of serious bodily injury on such person.

Special Allegation 1

It is further alleged that in the commission of the foregoing offense, the defendant personally inflicted great bodily injury on another person, other than an accomplice, within the meaning of Penal Code Section 1192.7(c)(8).
