The undersigned is informed and believes that:

#### COUNT 1

On or about June 3, 2024, in the County of Santa Barbara, the crime of ARSON OF AN INHABITED STRUCTURE OR PROPERTY, in violation of **PENAL CODE SECTION 451(b)**, a Felony, was committed by ROCKIE DAREN GINTER, who did willfully, unlawfully, and maliciously set fire to and burn and cause to be burned an inhabited structure and inhabited property located at 1423 GENOA WAY.

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section** 1192.7(c)(14).

It is further alleged that the above offense is a violent felony pursuant to **Penal Code Section** 667.5(c)(10).

## SPEC ALLEG - PC667(d)(1),(e)(1) - STRIKE PRIOR

It is further alleged pursuant to PENAL CODE SECTION 667(d)(1),(e)(1), PENAL CODE SECTION 1170.12(b)(1),(c)(1), and PENAL CODE SECTION 1192.7(c)[1192.7] and 667.5(c) that said defendant ROCKIE DAREN GINTER, suffered the following prior convictions of a serious or violent felony or juvenile adjudication:

It is further alleged, pursuant to **PENAL CODE SECTION 451.1(a)(1)** that the following aggravating factors exist: the defendant has been previously convicted of a felony violation of Section 451 on 04/05/2005 in the Superior Court of Santa Barbara County in case number 1179044.

## SPEC ALLEG - ARSON WITH AGGRAVATING FACTORS

It is further alleged, pursuant to **PENAL CODE SECTION 451.1(a)(5)** that the following aggravating factors exist: the defendant committed arson as described in subdivision (a), (b), or (c) of Section 451 and the arson was caused by use of a device designed to accelerate the fire or delay ignition.

## SPECIAL ALLEGATION: AGGRAVATING FACTORS

It is further alleged as to Count 1, that the People will seek findings from the jury on factors in aggravation pursuant to California Rules of Court, Rule 4.421 that:

## Pursuant to California Rules of Court, Rule 4.421(b):

(b)(1) The defendant has engaged in violent conduct that indicates a serious danger to society; (b)(2) The defendant's prior convictions as an adult or sustained petitions in juvenile delinquency proceedings are numerous or of increasing seriousness;

Pursuant to Penal Code Section 1054.5(b), the People are hereby informally requesting that defense counsel provide discovery to the People as required by Penal Code Section 1054.3.
