**FELONY COMPLAINT**

**AB109 INELIGIBLE**

The undersigned is informed and believes that:

COUNT 1

On or between January 1, 2018 and December 24, 2019, in the County of Santa Barbara, the crime of LEWD OR LASCIVIOUS ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(a)**, a Felony, was committed by STEVEN CARL SCHAPANSKY, who did willfully, unlawfully, and lewdly commit a lewd or lascivious act upon or with the body or certain parts or members thereof of JANE DOE 2, a child under the age of 14, with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of the said defendant(s) or the said child, to wit: WHEN DEFENDANT TOUCHED HER WHILE SHE WAS SLEEPING.

It is further alleged that the above offense is a violent felony pursuant to **Penal Code Section 667.5(c)(6)**.

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section 1192.7(c)(6)**.

It is further alleged that the Court shall prohibit all visitation between defendant and the child victim(s) pursuant to **Penal Code Section 1202.05(a)**.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

**SPEC ALLEG-STATUTE OF LIMITATIONS-MINOR**

It is further alleged, pursuant to Penal Code section 803(f)(1), that the victim in the above offense is under 18 years of age and reported the offense to a responsible adult and agency on 07/17/2024.

COUNT 2

On or between April 1, 2023 and April 30, 2023, in the County of Santa Barbara, the crime of LEWD OR LASCIVIOUS ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(a)**, a Felony, was committed by STEVEN CARL SCHAPANSKY, who did willfully, unlawfully, and lewdly commit a lewd or lascivious act upon or with the body or certain parts or members thereof of JANE DOE 27, a child under the age of 14, with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of the said defendant(s) or the said child, to wit: WHEN DEFENDANT TOUCHED HER WHILE SHE WAS SLEEPING.

It is further alleged that the above offense is a violent felony pursuant to **Penal Code Section 667.5(c)(6)**.

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section 1192.7(c)(6)**.

It is further alleged that the Court shall prohibit all visitation between defendant and the child victim(s) pursuant to **Penal Code Section 1202.05(a)**.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

**SPEC ALLEG – SERIOUS/VIOLENT/REGISTERABLE SEX OFFENSE FELONY**

It is further alleged, as to Count(s) 1 and 2, that the above offenses are serious felonies within the meaning of Penal Code section 1192.7(c) and/or a violent felony described in subdivision(s) of Penal Code section 667.5 and/or an offense requiring registration under the provisions Penal Code sections 290 et seq, pursuant to Penal Code section 1170(h), that the defendant is ineligible for a state prison sentence to be served in the county jail.

"NOTICE: Pursuant to Penal Code section 1170(f), notwithstanding any other provisions of this section, for purposes of subdivision (h) of section 1170, any allegation that a defendant is ineligible for a state prison sentence to be served in the county jail due to a prior or current conviction, or sentence enhancement, or because he or she is required to register as a sex offender, or because the legislature specifically excluded the offense, shall not be subject to dismissal pursuant to §1385 PC."

Pursuant to **California Rules of Court, Rule 4.421(a)**:

- (a)(3) The victim was particularly vulnerable;
- (a)(8) The manner in which the crime was carried out indicates planning, sophistication, or professionalism;
- (a)(11) The defendant took advantage of a position of trust or confidence to commit the offense.
