The undersigned is informed and believes that:

THE PEOPLE OF THE STATE OF CALIFORNIA

COUNT 1

On or about the 23rd day of September, 2024, in the County of Santa Barbara, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by JORDAN MANUEL GUTIERREZ, who did unlawfully, and with malice aforethought murder SHARLENE MARIE PLUNKETT, a human being.

It is further alleged that the above offense is a serious felony within the meaning of Penal Code Section 1192.7(c)(1).

It is further alleged that the above offense is a violent felony within the meaning of Penal Code Section 667.5(c)(1).

SPEC ALLEG – FELONY EXCLUDED FROM LOCAL CUSTODY

It is further alleged that the above offense is an offense for which the defendant JORDAN MANUEL **GUTIERREZ**, is excluded from a state prison sentence to be served in the county jail pursuant to Penal Code section 1170(h). "NOTICE: Pursuant to Penal Code section 1170(f), notwithstanding any other provisions of this section, for purposes of subdivision (h) of section 1170, any allegation that a defendant is ineligible for a state prison sentence to be served in the county jail due to a prior or current conviction, or sentence enhancement, or because he or she is required to register as a sex offender, or because the legislature specifically excluded the offense, shall not be subject to dismissal pursuant to §1385 PC".

SPEC ALLEG – SERIOUS/VIOLENT/REGISTERABLE SEX OFFENSE FELONY

"NOTICE: Pursuant to Penal Code section 1170(f), notwithstanding any other provisions of this section, for purposes of subdivision (h) of section 1170, any allegation that a defendant is ineligible for a state prison sentence to be served in the county jail due to a prior or current conviction, or sentence enhancement, or because he or she is required to register as a sex offender, or because the legislature specifically excluded the offense, shall not be subject to dismissal pursuant to §1385 PC."
